## **Contract Summary for Electronic Communications**

- This contract summary provides the main elements of Viber's electronic communications service offer as required by EU law for Electronic Communications providers.<sup>1</sup>

### **Services**

We provide ways for you to communicate with other users of our Services through messages, audio, video calls and video chats, sending images and video files.

Through our Viber Out service, we also allow you to communicate with telephone numbers of people who do not use our Services.

### **Price**

For our Viber Out service, we charge you through Viber Credits (pay as you go) or on a monthly subscription basis. Your Viber Credit balance will be reduced per actual consumption of our Viber Out services, according to our price list available here: <https://account.viber.com/en/rates-index>.

If you chose to purchase a Viber Out monthly subscription you will only be charged the recurring monthly charge of the specific subscription you selected, as indicated in your purchase flow, inclusive of taxes, until you terminate the subscription. There is no additional charge from us for activating our services, for equipment or other recurring or consumption-related charges.

Messaging and calls between Viber Users which are done through the free Viber service are not charged.

If you subscribed for our Viber Out service or another service on a subscription plan, there is no commitment period - the subscription is renewed on a monthly basis, unless you cancel it in accordance with our cancellation policy at no additional cost.

Where permissible under the law, Viber has the right to terminate your rights under our Service without notice, including, and without derogating from our general right, if you are in breach of our Terms and/or other policies or we decide not to provide the Services or any part thereof in certain locations or to certain devices.
