As part of our mission to spread good vibes, we want you to be able to share the things that matter to you most with your friends, family and anyone else around you. It's important to us that you feel comfortable and trust us with your data when using the Viber Services (as detailed under [Viber's Terms of Service](#)), including Viber payment services (if you use it). Please take a few minutes to read this Privacy Policy, so that you understand what data we collect, what we do with it and why, how we protect it and what are your rights in relation to this data.

In general, we collect data that allows us to provide you with an optimal experience while using our Services. This includes, for example, some basic benefits like allowing other users to see the name and picture you choose to show and the more advanced ones, like processing your registration and financial data to allow you to purchase our paid solutions, if you choose to use them. It also helps us to keep our Services clear of fraud and spam, and it allows us to get a unique understanding of what additional services may be useful to you, in addition to other purposes outlined in this Privacy Policy. You retain the ability to choose whether or not to provide your personal information to us. However, please be aware that if you choose not to disclose data that is essential for certain Services or features, we may be unable to offer you those specific Services, or process related inquiries.

Starting with Viber 6.0, Viber's core features are secured with end-to-end encryption: Viber one-on-one calls, one-on-one messages, group messages, private media sharing and linked devices. This means that the encryption keys are stored only on your devices and no one, not even Viber itself, has access to them. The Data We Collect

The operation and use of our Viber App and Services involves collection of personal data, where the types of such data depend on the type of Service and interaction with us. For example, when you sign up for Viber, you directly provide us personal data. We also automatically collect certain personal data from our users' device. We explain which information we collect and how we collect it below.

The types of personal data collected through use of our Services, including App and website, are listed below. We note that, some types of personal data we collect are required for all Viber Services (for example, your phone number), some types may be required solely for certain Services or features you decide to use (for example, Viber payment services), and some are optional, and subject to your discretion (for example, your photo).

[We do not read, listen or store your messages and/ or calls made privately:](#)

We wish to clarify that we do not read or listen to the content of your messages and/or calls made privately via Viber and we do not store those messages (including any media files transferred therein) once they have been delivered to their destination (which on average takes less than one second). If for some reason the message was not delivered to its destination within up to 2 weeks, it will be deleted from our servers. We note that we allow you the option to back up your chat history data on your own external data backup service (like iCloud or Google Drive) – see [HERE](#) for more info on backup.

[Data provided or collected through registration & under your Viber account or participation in Viber's activities:](#)

- **Identifiers**, such as:
 - Your mobile number (including mobile country/network code);
 - Your personal details (e.g., name, date of birth), if you provided them;
 - Your contact details (e.g., email address), if you provided them;
 - Your account login details, such as your username and any password or security pin-code, which you have chosen, if any;
 - Device identifiers, as described below.
- **Your photo**, if you provided it (e.g. any avatar).
- **Your phone address book**, meaning, the names, the phone numbers and the favorites list from your contact lists, if you approved access to them.

- If you choose to use our business accounts services, any personal data included in your **business account data**.
- **Interests** you choose to provide voluntarily.

Geolocation data:

- **General location**, we use IP addresses we collect and additional information (e.g., phone number area codes), to estimate your general location (e.g., city level); we may also use your residential address, if it's been provided by you.
- **GPS based location**, we will collect and use the GPS location for very specific purposes (as detailed below), and solely if you gave us permission.

Dating Data provided or collected through registration & usage of our dating services:

- **Dating Profile data** – your identification and account data, such as your name, date of birth, your gender, your dating preference gender, type of relationship you are looking for, your photos, your hobbies and interests, and any other information and content you choose to post on your dating profile such as your bio and a brief description of yourself, what are you looking to find, your habits, what you do for a living, your education.
- **Precise Location Data** – your accurate location (through and subject to your device permissions), is required and will be utilized to allow service functionality by finding you matches with the nearby participants of the dating services.
- **Dating Services Activity and Usage Data** – such as likes and dislikes of other participants' profiles, matches, profiles you hide/block, use of Premium Items and any paid features, inferences from such activities.
- **Sensitive Information** – as part of your registration to and usage of the dating services, we may collect and process certain types of information that could be considered sensitive and personal in nature. This may include your dating preferences, and types of relationship you are looking for, which are inherently necessary for matching you with potential partners, and other sensitive information, such as your religious beliefs, which you may choose to provide at your discretion. In addition, your use of AI features such as summaries, polish messages, instant answers, or other AI in-chat or chatbot features, may also involve information that could be considered sensitive and very private in nature, if you choose to provide it.
- **Biometric Data** – to verify that your dating profile is genuine and prevent impersonation, we process biometric data, subject to your consent, by comparing your profile photo with a selfie you provide. This involves analyzing unique facial features to determine whether the same person appears in both images, for which we only keep a score with the result of this analysis while your dating profile is active.

Financial information provided or collected through your use of our financial services (e.g., payment solutions), or purchased subscriptions and offers:

- **Purchased subscriptions, products or services:** If you purchase or subscribe to our Premium Services (e.g. a Viber Out, Viber Plus, Viber eSIM and other applicable plans) on our App or websites, we will process your billing data (e.g., full name or your user name, phone number, payment method), as well as

transactions-related information (e.g., the purchasing amount; date of purchase, currency; plan information, transaction result, IP address, country, first and last 4 digits of your credit card).

- **Viber Chatbot Payment Transactions:** Transactions-related details (transaction ID, time and date of purchase, purchase description, purchase amount, currency, the merchant transaction result, user free text entered information).
- **Viber payment services:**
 - Know Your Client ("KYC") or Know your Business ("KYB") data – including full name, date of birth, phone number, nationality, email, country location, national identity document, selfie, address and proof of address, source of funds and confirmation of the KYC verification status (i.e., approved or declined), KYC level, KYC errors, tax ID (where required in a certain country), other registration information business name, other related documents specifically requested as part of KYC/B;
 - Transaction and wallet-related information – including your digital wallet balance, details of the tokenized version of your credit/debit card, details of your wallet such as your IBAN, wallet ID and Swift code or wallet account, payment transaction information (including the instruction ID, payment method, fees, exchange rate, amount, currency, date and time, status of the payment, payment references, group ID, if payment in the group is made, fraud related information). In addition, if you send or receive payments or interact with other persons, we may have access or otherwise store the sender's or recipient's account details (e.g., wallet details and bank account details (including full name, country location and IBAN and Swift/ BIC code), wallet details (including wallet ID), details of the tokenized version of the credit/ debit card, payment IDs, payment information (i.e. merchant category code, type, authorization code, payment method information, country, address, date of birth, name, phone number, email, status in a promotion);
 - Utility bills payments information, such as your invoice or receipt for the utility bills, date of issue, total value, name of your utility provider, his tax number, address and payer's name.
 - Hashed pin code.

Data we collect automatically from your device, e.g., data collected using cookies and other device identifying technologies ('**Cookies and Tracking Technologies**')

- **Device identifiers**, meaning identifiers of the devices you have used to access our websites and applications, including IP address, unique device identifiers (including hashed phone numbers/emails), advertising related identifiers, MAC identifiers. Unique identifiers tell your device apart from other users and may be assigned to your device by Viber or our advertising service providers/partners.
- **Electronic network activity data**, such as information stored on log files, when you access our Service and website for example, including access time and date stamp, pages viewed, IP address, the pages that directed you to our website, information related to errors and crash reports.
- **Activity data**, relating to your usage of Services, such as connection status, whether you have received and seen messages sent to you, if you are currently on another call and data related to the calls and messages that you send and

receive, such as length of the call, who called who, who messaged who, and at what time, your personal preferences related to such usage (for example how often, for how long, what options are selected). Such activity data may also include:

- We may collect activity data about groups, communities, channels, bots, businesses, dating services, and links you interact with inside Viber – e.g. data about the groups, communities, business accounts, dating profiles and channels you visit, follow or manage, messages you like, messages you send, the content you post or view, links you click on;
 - Items you searched on and shared via Viber features;
 - Offers and rewards selected or redeemed;
 - Viber Premium Services, payment services or business accounts activity;
 - Dating Services Activity and Usage Data.
- **Other device data**, e.g., data about your device's operating system, your browser, browser or operating system language, your wireless network, your mobile carrier, your privacy-related settings.

[Data we collect or receive from other sources and inferred data:](#)

- **Social media data:**
 - If you have signed in to the app through third party social media sites – your email address, birthday and gender – if such information has appeared on your social media profile – was collected. Note that we disabled the option to sign in to the app through user social media accounts, and we no longer have any access to the current data from the social media accounts of users, who have signed in to Viber in such fashion in the past.
- **Your contact name**, as saved on other users' devices if they chose to share their contacts with us.
- **Viber may also process inferences about your account and device identifier**, such as:
 - Inferred gender – for example, inferred from your name;
 - Inferred interests – inferred from your activity, such as the communities, channels, bots, businesses, dating profiles or other Viber services, features and links (including the public content accessible through them) you interact with inside Viber and from other Data provided or collected through registration & under your Viber account or participation in Viber's activities. For example, your general location, travel patterns inferred from it, device type, and activity data within our services may be used to infer your income level;
 - Inferences from third party data and ads-related interactions – we may receive inferred data, linked to your device identifier (mainly, a unique device identifier generated by cookies or other tracking technologies used on our website and Services) from our trusted third-party advertisers and service providers. Such inferred data we receive may include inferences about your interests and characteristics, generated by such third parties

from other websites and services you have visited (for example whether you are interested in fintech, cars etc., which income group you might pertain to, as well as the locations you tend to visit, based on your GPS location). In addition, inferences can be generated from data on how you interact with ads displayed on our App after clicking on them and data about your activity and preferences derived from the clicks on our own ads (and the subsequent installs of our App) associated with your device identifier, delivered on third party's advertising platforms by our trusted third parties. - **eSIM data:** For eSIM services, we receive data from our third-party network providers such as eSIM identifier data (e.g. ICCID, IMSI, activation code), data consumption information (e.g. data volume used and session timestamps), and location (e.g. country, network routing, MCC, MNC).

[User Submitted Content:](#)

If you choose to participate in Viber's activities (e.g., contests), or as part of your participation in communities/channels/bots' activities available on Viber, you may voluntarily publish, submit or post content such as videos, images, graphics, text, etc. which may include personal data (e.g., an image of a person).

When you use AI features like summaries, polish messages, instant answers, or other AI in-chat or chatbot features, we process your text messages or content you choose to use with the feature to provide you with the translated or summarized message or to provide relevant responses or suggestions. This may include information that could be considered sensitive and personal in nature, if you choose to provide it.

[Data we collect from your communications with us, including support, customer services and other inquiries:](#)

If you choose to contact us through any means of communications we make available, you may provide us with certain information such as your contact details (e.g., name, email, phone number, mobile carrier, country – mainly where you are not a user of our Services) and other information you provide (mainly, related to the issue you wish us to address or resolve, including without limitation, information related to disputed transactions). In certain cases, such as when you request to exercise your data protection rights or when we need to verify account ownership, we may ask you to provide identification documents or other proof of identity, which will be used solely for verification purposes and retained only as long as necessary to complete the verification. We will further store our contact history and correspondence with you.

When you submit feedback, ideas, suggestions, information or other communications to us through our Services, we may collect any personal data if you choose to provide it.

[Non-User Data:](#)

Mobile phone number and contact name, as saved on a Viber user's phone address

book: We may process your mobile phone number even if you are not a Viber user, in the event that your phone number was included in our existing user's address book that has

been provided to us (and subject to such user providing us with approval to access the device address book). We will also save the name it was saved under by our user. We do it to show our user who in their contacts is already using our Services and who is not, to allow users find and communicate with their contacts who are users or who are not users in a more efficient way, and solely for as long as a relevant Viber user's account exists on Viber. In the event you will become an active user, the existing users whose phone book included your number, will be notified that you have joined the Service and you will be automatically added to their contact list within the Viber App.

Caller ID: Your phone number and contact name (if provided to us by a user through sharing their contacts or otherwise) may be added to our Caller ID database and used as part of the caller identification under Viber Caller ID or Viber In feature. Your name can be indicated to Caller ID or Viber In users when you are on a call with them outside Viber or used to show them a probability of spam, if such number has been marked as spam by users. Such process enables Viber to improve our services with the purpose to reduce spam, fraud and harassment for our users.

When you communicate with us for business purposes as a business partner of ours, we will save your contact data provided by you (e.g. names, phone number, email address, address), as well as any correspondence we have had. We use trusted third-party providers to manage the maintenance and storage of such data.

If your business account is connected with your Viber payment services wallet, we will collect in addition:

- your ID or certificate of registration with relevant authority;
- address of your business and contact details (e.g. email and phone number);
- tax information (e.g. certificate of registration with relevant authority, TIN).

[At Viber, we use your personal data to provide you with the best possible Service. This includes administering your account, customizing and improving the Service we offer, processing payments, serving ads and marketing campaigns, providing you with support and for compliance and safety reasons. We explain below the purposes for which we collect and use your personal data, as well as the types of data we use for each purpose.](#)

You can find here information regarding the purposes for which we collect and use your personal data.

Viber uses your personal data only when there is an applicable legal ground to do so. This may include situations where using your data is necessary to provide the services to you, meet our legal obligations or where you have given your consent. Where applicable, we may also rely on our legitimate business interests, provided that such interests are not overridden by your rights and freedoms. If you use our Services from the EEA or the UK, information about our lawful bases for processing of your personal data is detailed in our [EU Region Privacy Notice](#).

Authentication and Account Administration:

Viber uses different types of your personal data to create and administrate your Viber account in order to enable you to register, log in, activate and use the Services. This includes, for example:

- To authenticate and verify your account, as well as to make sure you do not already have a Viber account;
- To synchronize your contact list on the App (meaning, in order to show you your contacts on the Viber interface so you contact them through Viber or hide them on your dating profile if you choose so);
- To create your profile, customize your Viber account according to the information you have provided (e.g. name or photo), and display such information as part of your profile when you use Viber Services.
- Creating your dating profile, including verification of your eligibility to use the dating services. As part of such process you might be required to provide a copy of your ID or similar documentation. We will not retain such copies for a period longer than required for the verification process.
- If you choose to voluntarily verify your dating profile, we will process your Biometric Data. This involves comparing a selfie you provide with your profile photos using facial recognition technology, to confirm that the person in the profile is you. This helps prevent impersonation and fake profiles by detecting your genuine presence on the other end of the device. We process the selfie and the facial data to generate a verification score, a numeric result indicating how closely the images match. After verification, we only keep this verification result for possible future review (e.g. if your profile photo is edited or removed). We do not store or reuse the biometric templates or facial geometry data. This information is stored only as long as your dating profile is active. If you change or remove the profile photo that was used during verification, your verified status will no longer apply, and you'll be asked to complete the verification process again to keep your dating profile marked as verified.

The types of data we will use for such purpose will mainly include (as detailed in the [“Data We Collect”](#) section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers, dating profile data, your photo and phone address book;
- General location;
- Data we collect automatically from your device, such as device identifiers and other device data;
- Data collected from other sources such as social media data and your contact name, as saved on other users' device.

Provide our Services – Communication & Content Features (messaging, voice and video calls, group chats, communities, channels, dating services, business accounts, bots, chat extensions, explore screen, stickers, Viber lenses, etc.), and enabling backups:

Viber uses different types of personal data in order to operate, provide and deliver to you our Services, including communication features. This includes, for example:

- To allow mobile carriers to connect calls to you and from you;
- To show your online status;
- To enable you to send and receive messages, participate in Viber calls, delete messages;
- To provide you with other App's features such as operational notifications (e.g., missed calls);
- We will use your IP address to extract your approximate location, in order to enable you to use certain features that are only available in certain countries (for example, sticker packs);
- Provision of the dating services, including through making your dating profile available for other dating services participants, matching you with other potential matches (including by our automatic matching system), and allowing you to interact with such matches;
- Enable you to upload and create backups of your messages on external services;
- Enable you to post and share your User Submitted Content (e.g., images, videos, texts) on our communities, channels, bots, dating and business services, where allowed by its administrator, and generally utilize our content features;
- Send you operational related and service-related communications, including administrative messages that relate to your use of the Services;
- Subject to the permission you provide, enabling you to share your location with your contacts or enabling location-based services for you.

The types of data we will use for such purpose will mainly include (as detailed in the **"Data We Collect"** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers, your phone address book, your dating profile, your business account;
- Geolocation data, and precise location data for the dating services;
- Data we collect automatically from your device, such as device identifiers, electronic network activity data, activity data and other device data;
- Data we collect from other sources, such as social media data;
- User Submitted Content.

As stated above, your messages will not be stored by us once they have been delivered (Viber Dating chats excluded, as described in the Data Retention section).

Enabling Your Use of Viber Premium Services and Viber Chatbot Payments:

Viber uses different types of personal data in order to enable your use and purchase of Premium Services on our App or website, including for verification purposes. This includes, for example, sharing your email address with our third-party Payment Service

Providers, to enable the processing of your payments. Your credit card number will be provided by you directly to the applicable Payment Service Provider and Viber will not have unmasked access to this data. We will further store a log that will record your purchase for operational and fraud detection purposes, and such log will include your IP address or other device identifier.

We also use certain types of data to enable you to interact and pay to third party merchants through your use of the Viber Chatbot Payments. This data will be used solely for fulfilling our role as an intermediary and we will share with Google Pay or Apple Pay or any other linked payments provider. The confirmation of the payment is provided directly to the merchant and Viber does not receive or share any payment data or registration data from Apple Pay nor Google Pay. Note that, your use of Apple Pay and Google Pay, including their use of your data, is subject to their respective terms and privacy policy, which can be found here: [Google Pay](#), [Apple Pay](#).

When you purchase an eSIM, we partner with trusted network and telecommunication partners, who process network connection data independently. Viber does not access the content of your communications.

The types of data we will use for such purpose will mainly include (as detailed in the **"Data We Collect"** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers;
- Financial-related information, such as:
 - for purchased subscriptions, products or services – billing data (e.g., billing address, full name or user name, phone number, account, payment method), transactions-related information (e.g., the purchasing amount date of purchase currency; IP address, country, first and last 4 digits of your credit card);
 - for Viber Chatbot payment, transactions-related details including shopping history (transaction ID, time and date of purchase, purchase description, purchase amount, currency, the merchant, transaction result, user free text entered information).
- eSIM data

Enabling Your Use of Viber payment services:

As part of the Viber payment services, Viber provides limited financial services via licensed partners or together with the licensed partners. In order to provide this, we use certain information and share it with the licensed partner. This includes, for example:

- Identifying you in order to enable you the use of the Viber payment services;
- Sharing certain KYC/B and payment data you provide with the Payment Service Provider, where it may in turn share with downstream banks, Payment Service Providers, messaging systems, such as SWIFT, to enable the payment processing. Viber will not share information more than is strictly necessary (some information is collected directly by the Payment Service Provider and is subject to their Privacy Policy);

- Enabling you to easily make future transfers to a beneficiary's bank account or wallet account, to which you have previously made a payment transfer;
- Enabling you to pay your utility bills using Viber payment services and our payment services provider;
- If you make a payment we share with the recipients some of your personal details such as your name and IBAN;
- If you are a Viber user who is not registered with Viber payment services, but you interact with Viber payment services users by sending or receiving funds, or being part of a promotion, then the following information about you may be stored and used: the sender's or recipient's account details (e.g., bank account details (including IBAN and Swift/ BIC code), wallet details (including wallet ID), details of the tokenized version of the credit/ debit card, payment IDs, payment information (i.e. merchant category code, type, authorization code), payment method information, country, address, date of birth, name, phone number, email, status in a promotion.

The types of data we will use for such purpose will mainly include (as detailed in the **"Data We Collect"** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers;
- Financial information, such as Know Your Client ("**KYC**") data, transaction related information, your IBAN and wallet ID, your email address and bank account details of recipients to whom you have made a payment transfer;
- Data we collect automatically from your device, such as device identifiers.

Enabling and Managing Your Participation in Contests & Marketing Activities:

If you voluntarily choose to participate in contests and other marketing activities offered by Viber, we will use different types of personal data, depending on the applicable activity, in order to enable your participation and operate such activities. This includes, for example:

- If you participate in a contest which involves a prize, we will request you to provide your physical address in order to ship it to you;
- As some contests or activities are applicable solely to specific regions, we will use your general location (for example, according to your phone number area code), to validate your eligibility to participate in a specific contest.

The types of data we will use for such purpose will mainly include (as detailed in the **"Data We Collect"** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers;
- Data we collect automatically from your device;
- General location;
- User Submitted Content.

Improving and Customizing the Service and Analytics of Viber Activity:

Viber uses different types of personal data in order to improve, enhance and evaluate the Services, as well as customize the Services. This may include, for example:

- We use activity data, device identifiers, IP-based location, user feedback you choose to provide or communications to us and, with your permission, GPS location to fix and evaluate the technical functionality and availability of the Services, as well as for statistical analysis of the usage and functionality, product development, continued improvement of existing features and provision of certain features;
- We use your data provided through registration and inferred data (such as inferred gender, age range, inferred interests and general location) to customize content we show you, including customized our offers of certain services;
- When we advertise our Services to you on third party platforms, we might receive indications of which advertisement led you to join our Service based on unique device identifiers associated with your device, in order, among others, to assess the performance of our campaigns, to look for similar users, for better ad measurements, as well as to learn more about your activity and preferences on our Services.

The types of data we will use for such purpose will mainly include (as detailed in the **“Data We Collect”** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers;
- General location;
- Data we collect automatically from your device, e.g., data collected using cookies and other device identifying technologies, such as device identifiers, electronic network activity data, activity data and other device data;
- Data we collect from other sources and inferred data, such as social media data, your contact name and inferences about your account and device identifiers.
- Data we collect from your communications with us, including support, customer services and other inquiries, feedback, ideas, suggestions, information or other communications.

Marketing Communications with Viber’s Users & Location based Offers:

Viber uses different types of personal data in order to contact you with marketing and offers relating to products and services offered by Viber, and our third party trusted partners, in line with applicable laws. This may include, for example:

- We will use your email address, name, inferred gender, age range, certain dating profile data, device and activity data for the purpose contacting you with marketing and offers relating to products and services offered by Viber, and our third party trusted partners. When advertising Viber services outside of Viber, we might share your email address or device identifiers with our trusted marketing vendors;
- Your IP address will be used to extract your general location (city level), for the purposes of presenting offers applicable to your region;

- Subject to the permissions you have provided, we may use your GPS location data for the purpose of providing you with location-based marketing offers, and communications.

Please note that even after you have chosen to unsubscribe (see how you can do it in [“Your Choices”](#) section), we may send you service-related communications, including administrative messages that relate to your use of the Services.

The types of data we will use for such purpose will mainly include (as detailed in the [“Data We Collect”](#) section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers or dating profile data;
- Geolocation data;
- Data we collect automatically from your device, such as device identifiers, electronic network activity data, activity data and other device data;
- Data we collect from other sources (including publicly available resources and trusted third parties) and inferred data, such as social media data and inferences about your account and device identifier.

Advertising:

Viber uses different types of personal data in order to provide our advertising services (meaning, to enable the display of advertisements, including personalized advertisements provided by third party advertisers, in our App and Services), to measure and optimize the performance of ads and deliver more relevant ads. This may include, for example:

- Viber will use and may share your device identifiers (mainly, a unique device identifier generated by cookies or other tracking technologies used on our website and Services, or other identifiers that tell your device apart from other users and may be assigned to your device by Viber or our advertising service providers/partners), as well as age range, inferred gender, and reduced IP address (or, with your permission, GPS location data) with third party advertising partners, for the purpose of presenting you with personalized ads;
- Viber may collect and use your Viber activity data, and information we receive from third parties on your activity outside of Viber, and certain dating profile data, for the purpose of personalized advertising.
- We will not use any of your sensitive data for advertising purposes.

Additional information (including how to opt-out of data collection through the use of cookies) is available on our [Viber Ads, Cookies & Tracking Technologies Policy](#).

The types of data we will use for such purpose will mainly include (as detailed in the [“Data We Collect”](#) section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers (e.g. your mobile phone number country code; your personal details, e.g., name and date of birth, if you provided them);
- Geolocation data;

- Data we collect automatically from your device, such as device identifiers, activity data, and other device data;
- Data we collect from other sources and inferred data, such as social media data and inferences about your account and device identifiers.

Customer Service:

Viber uses different types of personal data in order to provide customer service and customer support. This may include, for example:

- We will use your contact details to communicate with you, give you information about your account, and respond to your requests;
- We may use your contact history and correspondence with us for the purpose of improving our Services, training our support team as well as internal management operation.

The types of data we will use for such purpose will mainly include (as detailed in the **“Data We Collect”** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers and your phone address book;
- Geolocation data;
- Financial information provided or collected through your use of our limited financial services (e.g., payment solutions), or purchased subscription and offer;
- Data we collect automatically from your device, such as device identifiers, electronic network activity data, activity data and other device data;
- Data we collect from other sources and inferred data, such as social media data;
- Data we collect from your communications with us, including support, customer services and other inquiries.

Safety, Security & Fraud Prevention:

Viber uses different types of personal data for security purposes such as fraud and spam prevention. This may include, for example:

- We will collect and examine URLs included in messages or messages, which were reported by other users, or were otherwise suspected to be unsolicited and using your device operating system authentication services;
- We will use some of the information connected with the use of Viber payment services to prevent fraud and ensure security of your wallet account;
- We may examine the content related to your business account to ensure users' safety and prevent fraud;
- We may use data from trusted third parties to enhance the precision in detecting fraudulent activity;
- Monitoring of your conduct and use of the dating services to prevent fraud, misuse, harassment and other unlawful conduct;
- We may use automated decisions to close or restrict an account based on such data and other logic we have created for this, in order to protect other users and prevent recurring breaches. If your account has been blocked, you can contact our support.

The types of data we will use for such purpose will mainly include (as detailed in the **“Data We Collect”** section above):

- Data provided or collected through registration & under your Viber account, such as Identifiers, business account or dating profile and usage data;
- Geolocation data;
- Financial information provided or collected through your use of our limited financial services (e.g., payment solutions), or purchased subscription and offers;
- Data we collect automatically from your device, such as device identifiers, electronic network activity data, activity data and other device data.

B2B Communications and Services:

We will use Business Partners Data (as detailed in the **“Data We Collect”** section above) for the purpose of communicating with you, or as otherwise needed to facilitate our engagement, as well as to send you our marketing offers. You have the ability to opt out of our direct marketing emails at any time (see how you can do it in **“Your Choices”** section). Email addresses provided as part of the access to Viber business related features and APIs are collected and processed to enable your access to such features and APIs, enable account functionality, provide visibility and tracking of account actions (such as template management and deletions), maintain the security of account activity, and for fraud prevention and investigation purposes. Login data for Viber’s internal resources (e.g. secure portals and knowledge bases) is collected and processed to manage and secure your access to such resources. We also process Business Partners Data to analyze how our business services are used and to improve our service offering.

Provide services using Non-User Data:

We will store and use Non-User Data (as detailed in the **“Data We Collect”** section above) which includes non-Viber users’ phone number (and names under which they were saved by Viber users) in the event such contact was included in our user’s address book that has been provided to us, for the purpose of showing our user who in their contacts is already using our Services and who is not, to allow the user find and communicate with their contacts in a more efficient way, through regular Viber and Viber Out communications.

We also store and use Non-User Data to indicate your name to Caller ID or Viber In users when you are on a call with them outside Viber or to show a probability that your number is spam, if it has been marked as such by users, for the purpose of reducing fraud, spam and harassment for our users.

Defend our Rights, Enforce our Policies & Compliance with Legal Obligations and Public Interests:

Viber may use and share different types of personal data, and depending on the circumstances, for the purpose of defending our rights and enforcing our policies, terms and agreements, where it is necessary to comply with legal obligations to which we are

subject to and cooperation with regulators and law enforcement bodies (where there is a valid legal request such as binding order), as well as in very limited and rare circumstances, where we find it necessary and essential for the purpose of protecting your or third party's life safety and security as well as humanitarian purposes. This may include, for example:

- In the event of a dispute, claims and legal proceedings, and solely to the extent necessary for such purpose;
- We may record and log some of your actions, such as acceptance of our terms and policies, acceptance of certain offers, and notices;
- We will store an indication of your request to exercise your rights related to your personal data in order to be able to demonstrate compliance;
- We may store telecommunication data in accordance with local laws;
- We may be required to provide authorities with information in compliance with criminal investigations laws applicable to electronic communications provider or otherwise applicable to us;
- We may examine the content you upload in relation to your business account or dating profile to ensure the enforcement of our policies and compliance with applicable laws and regulation, including per our [Acceptable Use Policy](#), [Dating Community Guidelines](#) and [Viber Business Accounts Terms and Conditions](#);
- For financial, tax or audit reasons.

What Other Users Can See

When you use our Services, other Viber users can see certain data about you, for example, the fact that you are a Viber user or a user of certain Viber Services, the content you voluntarily share, your profile information (subject to your settings), your connection status, as we further detail and explain below.

Other users can see on Viber the following data about you:

- Unless you have changed your settings:
 - your user name and photo;
 - your phone number (if you are in communication with them or have a business account);
 - your connection status;
 - whether you have received and seen messages sent to you;
- If you are currently on another call.
- If they are part of the call with you, data related to the calls and messages you have sent and received such as length of the call, who called who, who messaged who, and at what time, the type of call (audio/video) and whether you answered the call on your primary or another device.
- For disappearing messages, we will notify the other users of any screenshots you've taken (so please respect the vibe and do not take them).
- Your name and photo may be shown to Viber Caller ID or Viber In users when you initiate a phone call with them (on Viber or mobile).

- When you join Viber, the contacts in your address book that are already Viber members may be informed that you're now on Viber too.
- A reminder about your birthday on the date of your birthday unless you have changed your settings.
- If you are a Viber Plus subscriber and have your Viber Plus badge enabled, we may show to your contacts that you are a Viber Plus subscriber (including your name and profile photo) when we promote Viber Plus in the App.
- When you join Viber payment services, the contacts in your address book that are already Viber members may be informed that you're now using Viber payment services. In addition, Viber users will see an indication whether you are a Viber payment services user and perform in app transactions with you.
- When you send money using Viber payment services, the recipient can see transaction and other related information including the IBAN, swift code, sort code, account number, amount, time, payment reference and for group payments the purpose and payment status of others in the group. The sender will see certain letters of the first and last name of the recipient, if the recipient of the transaction is not in the sender's address book, so that the sender may verify that the recipient is a correct beneficiary of the transaction.
- If your "Use Peer-to-Peer" option is on, other users can use technical tools to see your IP address. You can turn this option off at any time on your privacy settings.
- **Your public posts:** if you post information on our public spaces such as communities, channels, business accounts, dating profiles, it may be searchable and available to other users on Viber. You can always delete your posts on those public spaces, but Viber cannot control and is not responsible for what other users do with this information (e.g., store on their devices, publish on Viber or outside of it, etc.), thus, we recommend you do not disclose your personal data through the content of your posts.
- Quality indicators and tags on your business account (e.g. responsiveness and activity indicators, categories) or dating profile (e.g. activity indicators) assigned by Viber, which are intended to provide other users more meaningful information about your business account or dating profile.

How We Share Your Personal Data

We share data with third parties, including our corporate family and with trusted companies that help us provide our Services in compliance with strict data security and privacy practices, as well as other third parties such as our advertising partners, and third parties offering services through our App. We may also share personal data in limited circumstances where we are required to do so under applicable law. You can find [here](#) information about the categories of such third-party recipients, as well as the purpose for which the personal data is shared with such third parties.

Your data is kept safe with us, but we do share your personal data with third parties we trust, solely as follows:

The Viber Corporate Family:

We may share the data we collect about you with the Viber corporate family, including our parent company, Rakuten Group Inc., and its and our affiliates (as listed [HERE](#)) and our subsidiaries, for the following purposes:

- Certain types of data, such as name, personal email, avatar, phone numbers, Viber unique ID, may be disclosed in order to provide joint content and our Services (e.g., registration, coordination of membership accounts between the Viber corporate family, transactions, analytics and customer support);
- Additionally, we may share certain types of data about you as may be necessary to help detect and prevent potentially illegal acts, violations of Viber policies, fraud and/or data security breaches;
- We share data with Viber's subsidiaries due to our global operations, as we have teams and offices located worldwide, and each such subsidiary may operate the services or other functions (e.g. development) for a certain region.

Your Rakuten account or any activity related to your use of Rakuten services is governed by [Rakuten ID Privacy Policy](#).

Our Service Providers:

We share your personal data with our trusted service providers and business partners that perform business operations for us on our behalf (as data processors) and pursuant to our instructions. This includes the following types of service providers:

- **Advertising, sales and marketing service providers**, who help us conduct, manage, measure and support our advertising, promotional, sales, marketing, user acquisition and user engagement activities and campaigns;
- **Data storage providers**, with whom we entrust the hosting and storage of our data;
- **Customer support providers**, who help us perform such functions as customer support and customer service;
- **Data analytics and data management providers**, who help us analyze, improve, personalize, enhance our Services and moderate the content;
- **Measurement partners**, who help us with measurements, tracking and targeting;
- **Payment and fintech services providers**, who enable processing payments and fintech actions on our app;
- **Network and telecommunication partners**, who help us support communications and other services to users;
- **AI service providers and partners**, which enable AI features on our app, including summary, in-chat assistance, chatbot features, etc.;
- **Data security partners**, who help us detect and prevent potentially illegal acts, violations of our policies, fraud and/or data security breaches and ensure compliance with legal obligations.

Where we share information with service providers and partners, we ensure they only have access to such information that is strictly necessary in order for us to provide the Services. These parties are required to secure the data they receive and to use the data for pre-agreed purposes only, while ensuring compliance with all applicable data protection regulations (such service providers may use other non-personal data for their own benefit).

Third-Parties Offering Service Through our App:

As part of Viber's Services, we allow third parties to create communities, channels and business accounts on Viber, and develop through the use of Viber's API their own bots, chat extensions and integrate into Viber explore screen in order to communicate with Viber users ("**Third Party Communications**"). In the event you voluntarily choose to interact with the Third-Party Communications through your use of the Services, such third parties may receive certain data about the user, such as your user's name, photo, country, some device data and Viber unique ID. These third parties are **not** processing the data on our behalf, meaning, their use of your data shall be subject to their policies and privacy practices.

Advertising Partners:

To enable the limited advertisements on our Services, we may share device identifiers (i.e., an advertising identifier associated with your device or identifiers that tell your device apart from other users and may be assigned to your device by Viber or our advertising service providers/partners) with our third-party advertising partners (listed [HERE](#)), along with certain of your device data (e.g. language preference), age range, inferred gender, country, city, reduced IP address (or, with your permission, GPS location data) and certain technical or aggregated data about you and the device you are using. This includes partners managing our advertising placements, and also advertisers themselves and their agencies or third parties managing their advertising demands. Your unique advertising identifier is created by your mobile device's operating system and you can change it or choose not to share it at any time. If you want to know more, read our [Viber Ads, Cookies & Tracking Technologies Policy](#).

Legal and Law Enforcement:

Subject to our strict data security and privacy practices and without compromising our end-to-end encryption, we may disclose certain types of your data, including, and depending on the circumstances, Activity Data, Identifiers and your phone address book, to law enforcement, governmental agencies, or authorized third parties, in response to a verified request relating to terror acts, criminal investigations or alleged illegal activity or any other activity that may expose us, you, or any other Viber user to legal liability, and solely to the extent needed to comply with such purpose.

Corporate Transactions:

In the event of a corporate transaction (e.g., sale of a substantial part of our business, merger, consolidation or asset sale) we will share the data we store with our acquiring company. We will obligate the acquiring company to assume the rights and obligations as described in this Privacy Policy (including this notice), and we will notify you of such corporate changes in your data processing.

Limited Payment Services:

If you use our Viber payment services, we will share with our payment service providers KYC data, fraud data, payment requests/ instructions, specifically requested information (i.e. due to a specific issue), transaction and wallet related information.

If you use our Viber Chatbot Payment, we will share with Google Pay or Apple Pay or any other linked payments provider the following information: (i) name of the payment service provider merchant; (ii) price of the items purchased and currency; and (iii) the description of the items purchased. The confirmation of the payment is provided directly to the merchant and Viber does not receive or share any payment data or registration data from Apple Pay nor Google Pay. Note that, your use of Apple Pay and Google Pay, including their use of your data, is subject to their respective terms and privacy policy which can be found here: [Google Pay, Apple Pay](#).

If you purchase our Premium Services not through app stores, we will share your email address with our payment processor, for the purpose of verification and fraud detection.

Publishing and Making Your Dating Profile Visible to Other Users:

If you choose to participate in the dating services, the information included in your dating profile as well as any other content you choose to share, may be presented to other participants of the dating services. VIBER STRONGLY ENCOURAGES YOU TO USE CAUTION IN DISCLOSING ANY PERSONAL INFORMATION ONLINE INCLUDING THROUGH YOUR DATING PROFILE.

International Data Transfers

Due to our global operations, your personal data will be shared with Viber corporate family, as well as our service providers and business partners around the world. We take measures to ensure the transfer of such data will provide sufficient safeguards. These measures include compliance with Binding Corporate Rules of the Rakuten Group, as well as contractual commitments of our partners and service providers. We further explain below why we transfer personal data, the measures we take to ensure your personal data will be secure upon transfer, and your rights in this regard.

Due to our global nature, your personal data may need to be processed in countries where data protection and privacy regulations may not offer the same level of protection as in your home country. Depending on the territory from which you use our Services, we may store and process all categories of your personal data on our computers located globally, including in the United States, Asia, Europe, Russia, Australia and Brazil. In addition, our communications servers are located globally in order to enable the operation of our communications services and we use service providers that may be located in various locations.

Transfers of your personal data will be made in accordance with applicable data protection laws, and among others, we have put in place appropriate safeguards (such as contractual commitments) in accordance with applicable legal requirements to ensure that your personal data is adequately protected.

Furthermore, as part of the Rakuten Group, Viber relies on the Rakuten Group Binding Corporate Rules to legitimize international data transfers within the Group. The Rakuten

Group Binding Corporate Rules can be found at <https://corp.rakuten.co.jp/privacy/en/bcr.html>.

When personal data collected within the EEA (or UK) is transferred outside the EEA (or UK), we will take the steps necessary to ensure that the transfer of such data provides sufficient safeguards, and you may exercise your rights, where applicable, to receive information on such transfer mechanism, as further detailed under our [EU Region Privacy Notice](#).

Data Retention

As we have explained above, we process personal data for various purposes. Accordingly, we only keep personal data as long as required to fulfill the purpose for which the data was collected, or, in some instances, where we have other necessities to retain the personal data, for example, where required by law. We explain below the criteria used by us to determine the retention of your personal data (meaning, for how long we store it and when we delete it, aligned with the type of data and purpose of collection).

The criteria used by us to determine Viber's retention periods are as follows:

- The type of personal data and purpose of collection – unless otherwise specified, we retain data as long as it is necessary and relevant for us to achieve the purposes for which the personal data was collected. For example:
 - Personal data required to be retained in order to maintain your Viber account and to enable you the use of Viber Services – these types of data, including your mobile number, and phone address book, will be retained for as long as you maintain your Viber account.
 - Personal data you have voluntarily provided during registration or through your account (including dating profile or business account data) – these types of data, including your photo, date of birth, email address, will be retained for as long as you maintain your account.
 - The details of your communication with our customer support team will be stored for 10 years.
 - Call Detail Records of your free Viber calls and messaging activity, as well as records of your in-app activities (jointly, CDRs) are kept as a raw data for 24 months from creation. CDRs may include, for example, your phone number and device identifiers (i.e., IP address, unique device identifiers).
 - We delete any message once delivered, or after 14 days if delivery attempts throughout this period were not successful.
 - Viber Dating chats are retained on our servers for up to 3 months from the date they are sent. This retention period supports safety, security, moderation, and enforcement of our policies. Retention may be extended where required by applicable law, a pending legal hold, or an ongoing investigation.

If you decide to delete your Viber account, the CDRs and communications with our customer support will be retained as detailed above, and we will further retain records of financial information (with respect to Viber payment services this means KYC data, transaction and wallet related information or your hashed pin code), Viber Out usage including CDRs, purchasing subscriptions, for the periods required under applicable laws, or as needed in accordance with our fraud monitoring program or to identify a returning user (for Viber payment services).

All other types of data related to your Viber account will be deleted, unless we are required to further retain the data, subject to the criteria detailed below. We may keep measurement data and activity data on a non-identifiable basis to improve our Services and for business analytics purposes. Your posts on channels and communities may remain available if you do not delete them. Please note that deletion of the App (i.e., uninstall the App from your device) will not immediately delete your account, but if you do not reinstall it within subsequent two weeks your account may be deactivated; provided however if you have Viber Credit under your Viber Out account, other time periods will apply as set forth under "Viber Credits Specifications" clause of [Viber Out Service Specific Terms](#) and any eSIMs purchased through the App will remain active on your device independently of the App. Note that your account may also be deactivated if you do not log into Viber for twelve consecutive months.

- **Compliance with our legal obligations** – we are required to retain certain types of data in order to comply with our obligations under applicable laws. For example, we need to retain transactions information to comply with tax legislation. In addition, we may retain certain types of personal data in the event we are required to do so subject to a binding legal request or a court order. Further, subject to EU Directive 2002/58/EC we are required to retain certain personal data (such as phone number) to convey messages and calls.
- **Dispute, claims and legal proceedings** – if you have a dispute with us, we may retain certain types of personal data as necessary and applicable to your claims, including any legal proceedings between us, until such dispute was resolved, and following, if we find it necessary, in accordance with applicable statutory limitation periods. In addition, in the event you request to exercise your rights, we will maintain the applicable correspondence for as long as needed to demonstrate compliance, and usually in accordance with applicable statutory limitation periods.
- **Retention for Non-User Data** – if you are not a Viber user, and we process your data to enable Viber users to communicate with you via Viber Services we will retain such data as long as it is relevant to Viber users, or until you have requested us to stop processing your phone number. You can request to exclude your phone number and opt out [here](#). You can also opt out from the caller identification processing under Viber Caller ID or Viber In service by contacting us [here](#). Furthermore, if one of our users used our Viber Out Services in order to communicate with you (i.e., call you through Viber), we will retain a log of such call (Call Detail Records – CDR – as detailed above), which will include your phone number, for 24 months from creation. In relation to Viber payment services we store non-user data as long as it is relevant to a Viber payment services user (i.e. you are the sender or a recipient in a transaction with them or as part of a

promotion). Further, this information may be stored as part of our fraud prevention program or in response to specific customer queries.

Your Choices & Controls

The personal data is yours – the choice is yours too on how to customize your Viber experience. Viber users enjoy certain choices and controls related to their personal data. We explain below the controls and choices provided by Viber and how you may exercise them, including deletion of messages, privacy settings, the visibility of your online status, limit what other users can see, unsubscribe from marketing materials and opt-out of certain personalization features.

Viber provides you with certain choice and controls you may exercise, related to your personal data, as follows:

- We enable you to delete or edit your messages anytime, even after they have been sent (they will be deleted or appear edited for you, your friend and our Services).
- You can also control your privacy settings within the App to change the visibility of your online status.
- You can disable the “seen” notification so that other users do not know whether you’ve read a message yet.
- You can choose not to share your photo and/or birthday or not to allow other users to look you up by name, which are available within the App.
- You can also make additional choices on your phone’s settings by changing our App’s permissions such as GPS location sharing, access to contact list and more.
- You can choose not to display your Viber payment services badge.
- If you do not wish to receive Viber marketing notifications, you may adjust your system settings to decline notifications from Viber, or submit a request to our support. And if you subscribed to receive promotional emails from Viber, you can unsubscribe in any such email at any time.
- Sending a message to a bot, subscribing to a bot will allow admins of that bot to send you notifications and personal messages. If you do not wish to receive such notifications, you may adjust your account settings to decline them or opt-out at any time from receiving further notifications. You may also adjust your phone preferences to disable the use of your GPS location data at any time.
- You can choose to allow or to not allow customization and personalization of our Services provided to you based on your personal data, by changing your personal data toggles in the privacy setting within the App.
- You have even more choices (such as use Viber with no ads, invisible mode, deleting messages without a trace, etc.) under our premium Viber Plus service.

Your Rights Related to Your Personal Data

Subject to local law and your interaction with Viber, you may have certain rights regarding the personal data that Viber collects about you. Such rights may include the right to know which types of data we collect and why we collect it (as we detail under this notice), the right to request rectification of your personal data, the right to request us to delete your personal data, the right to opt-out of certain data collection, the right to access your personal data, the right to withdraw your consent, as well as the right to lodge a complaint to a supervisory authority. We further explain below the operational meaning of each such right, as well as when and how you may exercise your right.

Viber respects your ability to exercise certain rights with regards to your personal data collected and stored. In some areas and jurisdictions, such principal rights may include all or some of the following rights:

- **The right to be provided with information about our data collection and privacy practices** – including the sources from which we collect data, the purposes for which we collect and share data, the data we hold. This Privacy Policy describes our practices in detail using simple language. Everything you need to know is here. If you have more questions, feel free to contact our [support team](#).
- **The right to access your personal data** – you may receive your profile data by using the [request your data button](#) (see below) and for further access requests you can contact our [support team](#).
- **The right to request rectification the personal data we hold about you** – if you believe we have the wrong data about you, or that your data is incomplete, feel free to change your personal data at any time through the profile settings on your Viber settings on your mobile device. You may edit your dating profile data at any time through the dating profile (except for non-editable categories such as your name, age and gender). If you can't find what you are looking for, [contact us](#).
- **The right to erase your personal data – You can exercise your right to erasure in the following ways:**
 - **Delete your account or service-specific profile.** Deleting your Viber account is the most comprehensive way to erase your personal data from our servers. You can deactivate your account through your Viber settings, and upon deactivation, your data and chats will be automatically deleted from your devices. We will delete all data associated with your account, except data we are required to retain under applicable law (such as financial records and certain activity logs, as described in our Data Retention section). If you use specific Viber services that maintain a separate profile (such as Viber Dating or Business Account), you may delete your data either through removing the information from the non-mandatory fields of your service-specific profile or delete that service-specific profile entirely without deactivating your main Viber account. For example, you may delete your Dating profile through the Dating Settings in the App or your Business Account through the Business Account settings. Deleting a service-specific profile removes the data associated with that service.
 - **Delete your data while continuing to use the App.** We have also made it easy for you to request deletion of your historical **personal data from our servers while keeping your Viber account active** and allowing the continued use of the App. Simply tap on the **'Personal Data > Delete Your Data'** button in your privacy settings. We will delete the data which we are

not otherwise required to keep or is not necessary for the provision of the Service. And no need to worry – deleting your data won't remove the chats on your Viber App on your phone.

- Please note that content shared, sent or made available to other participants of the dating services prior to your account deletion may be retained and utilized by such participants, outside of our control and responsibility.

- **The right to restrict our use of your personal data** – We allow you to opt out of certain processing of your data by using the [Viber privacy settings](#) on your mobile device. You can decide which processing operations you want to opt-out of. Back-ups:

If you voluntarily choose to back up your Viber conversations, such back-ups are made by independent third parties and kept on your device's service according to operating system's (Google/ iOS) terms and policies and are no longer protected by Viber's end-to-end encryption nor Viber has any control over it. This is also true for using Viber Desktop – where your conversations are kept on your personal computer under your security definitions.

TrueDepth APIs:

Starting the end of June 2021 we added a new face lens feature that uses camera capabilities in order to add graphic elements on the user's face. Some lenses can make use of TrueDepth API. TrueDepth API is only active when those lenses are running. It is a very specific feature and none of the Viber lenses will be using it at the moment. Types of lenses that might use it are virtual try-on, which we don't have. Viber does not collect any data from these sensors or ever store it anywhere. The data never leaves the user's

device (so cannot be, and is not, shared by Viber with third parties) and is only used for lens operation.
